## POLICY 8.06

### **POLICY TITLE: NAMING OF NEW STREETS**

#### **PURPOSE OF POLICY:**

**To provide a guideline on the procedures to name new streets in the Village of Fruitvale and to recognize those individuals or families who have made contributions to Fruitvale.**

---

1. When naming a new street in the Village of Fruitvale precedence will be given to keep the name of the street in the same category name as the surrounding streets (ie: after trees, etc.).
2. In order for family names to be considered, submissions must be accompanied by written, anecdotal documentation, to include particulars as set out in the Nominee Submission Form, attached hereto and forming part of this Policy.
3. The selection shall be made from names approved by Council based on the following criteria:
  - 1.1 individuals or families who have made a significant contribution to the Village over a period of years;
  - 1.2 individuals or families who through their achievements have brought national or international recognition to Fruitvale;
  - 1.3 individuals who have made an outstanding volunteer contribution to the Village.
4. If more than one family name is submitted, approved names will be chosen by random draw.
