She noted that the building scheme needed to be protected in order to keep the design consistency and that the contractor was willing and expecting to do so, but at present the property development variance /development permit did not require the Village's approval of building plans.

She further noted that she is working with JHC's lawyer to provide assurance of Village approval of building plans, but in order to avoid undue construction delays and extra expenses to the contractor, she requested approval of the issuance of the first two building permits for foundation excavation and concrete at present.

CAO REPORT

October 6 for October 10th, 2017 Council Meeting

Finance

- The annual tax sale was held September 25, 2017; the Village assumed the sale for 1928 Beaver Street by default as no bidders attended. The property owner has one year to redeem the property.
- Water, cemetery and BV Recreation budgets are required to be submitted to RDKB by early October.
- Interim audit on site has been arranged for the week of November 27.

Administration

- Most of my time has been spent on Clean Water & Wastewater Fund project reporting and tenders, Davis Avenue road dedication finalization, RV Park costing (final report will be provided at November Council meeting), various financial reporting deadlines, grant claims and grant funding reports, as well as planning (subdivision, zoning, building, Board of Variance appeals and development application questions, etc.).

Human Resources

- Cross training is taking place for payroll.
- 2 Public Works staff are currently away or scheduled for required Continued Education Units training to maintain Environmental Operator Certifications.
- A Literacy Supporter Award was presented to the Age Friendly Coordinator by the Columbia Basin Alliance for Literacy at the September luncheon for her support and coordination of technology courses for seniors.

Other

- Bylaw Enforcement
 - Water restrictions remained the focus of enforcement with night-time irrigation non-compliance remaining the main issue.
 - Property standards and parking complaints have been September issues.
 - Windfall and unpicked ripe fruit and produce are being addressed currently.
- Sewer
 - Currently the headworks project and gravity main project tenders have been received and are being reviewed with the intention to reduce the cost by altering the equipment installation schedule.
 - The pipe bridge replacement is at tender stage.
- Water
 - The Waterworks Foreman reports that irrigation has reduced and that the Water Treatment Plant reservoir is now maintaining levels.
- Public Works
 - Paving and drainage construction projects for Evergreen Avenue and Pole Yard Lane are now let and the work will be completed by the end of October. Village crew will do the drainage work with sub-contractors. Selkirk Paving will do the road works.
 - Sewer connection replacement work was required on Birch Avenue.
 - Boulevard drainage works were completed at 1901-1903 Mountain Street.
 - Regular fall equipment maintenance, irrigation shut-downs are also ongoing.

- Facilities and Parks
 - Community Hall - Replacement of the walk-in cooler refrigeration system was required.
 - RV Park Project – The project is complete and the park is fully commissioned. We are awaiting plaques for the memorial benches currently. There have been 48 paid stays to date.
 - The Seniors' GYM expansion is underway with the removal of the basement kitchen and assessment of required works and engineering. An RFP will be released shortly to solicit construction proposals.
 - Creekside Community Park – there is a problematic beaver dam located in Beaver Creek which will be dealt with according to instructions from the Conservation Officer.
 - Haines Park – The Treasurer of the BV May Days Society met with me and would like Council to consider options for improvements to the Park to be funded by May Days. Their suggestion is for a shipping container with a mural on it for storage (particularly the tables and chairs which are problematic). Alternate options are concession improvements such as shelving. The topic is included under New Business for a more fulsome discussion.

- Age Friendly
 - The regular luncheons and coffee planning sessions have resumed.
 - The AF Volunteers worked on the Liberty Anniversary events and earned funds for programming.
 - The Dar family provided an additional donation to bring the amount up to \$2500 toward Age Friendly programming.
 - Regular attendees of the luncheons made donations specifically for an event to recognize the AF volunteers and an evening dinner has been held. Susan Dar worked with the AF Coordinator to provide the meal.

- We were able to make presentations for our proposed project to both Minister Selena Robinson and Minister Carol James

- We felt that our presentation and project was very well received. The Ministers staff sought us out during the networking receptions to talk further on our presentations.
- Director Ali Grieve attended the presentation with Councillor Webber and I and the “collaboration” was viewed as very positive
- Both ministries encouraged us to bring our project to Victoria after we have a final plan
- It was a great opportunity for networking. We were invited to have lunch with Urban Systems and met with the Interior Lumber Manufacturing Association, Interoute Construction, Columbia Basin Trust and FortisBC.

Some other highlights at the UBCM conference were:

Responsible Conduct Policy Paper Endorsed

- Delegates endorsed a policy paper that outlines an approach to strengthening the framework for responsible conduct by local government elected officials in B.C.
- UBCM’s Executive will follow up with Minister Selina Robinson to ascertain the provincial response to the approach contained in the policy paper.

Call to Protect the Most Vulnerable

- The Leader of the Official Opposition, Rich Coleman, addressed the UBCM membership with a message urging leadership from all levels of government to protect those who are most vulnerable.
- Mr. Coleman acknowledged the importance of UBCM leaders crediting a shared passion for leadership and public life, despite its challenges.
- Coleman encouraged local government leaders to stand up to “nimbyism” to ensure that supportive housing and addictions treatment facilities are built. He also said that the province currently spends \$2.8 billion annually to support those with mental health and addictions issues.
- Coleman referenced the need for the Province to support interior communities with significant dollars to rebuild so that “they know we care about them.” He also stated that the people that fought the fires should be honoured, thanked and remembered.
- Coleman said that the Liberal party will not ask taxpayers to provide campaign funding for its candidates and that he did does not support proportional representation.
- Speaking to the challenges inherent in public life, Coleman told delegates “When you get into politics, you have to know that eventually it ends badly for you.”

Wildfire Prevention and Mitigation

- Wildfire was a hot topic of discussion as delegates were provided a glimpse into the future of fire prevention and mitigation in B.C. With more than 1200 fires, 1.2 million hectares of land burned, 4000 evacuees and costs nearing \$500 million, this summer was the worst wildfire season in B.C.’s history.=
- Madeline Maley, Executive Director of the B.C. Wildfire Service (BCWS) assured delegates that a comprehensive review of BCWS and the FireSmart program is currently underway, along with the development of a research and innovation program for preventing wildfires. Part of the program development will involve BCWS determining the best way to engage with the public and work with other jurisdictions across Canada to develop innovative solutions to wildfire mitigation.

- In his presentation, Ian Meier, BCWS Director of Wildfire Management, outlined a set of tools that can help reduce catastrophic loss due to wildfire. He also said that BCWS is developing a website dedicated to wildfire prevention education and that two community engagement specialists have been hired to develop the site.
- Maley and Meier also indicated that controlled burns could soon be returning to B.C.'s landscape. Maley said there was support for using controlled burns selectively as an effective method of dealing with grasslands and some forest stands that pose annual threats to communities.
- Fire Commissioner Gordon Anderson and Phil Lemire, President of the Fire Chiefs Association of B.C., rounded out the presentation to the delegates.

FAN Council Updates September 2017

A big thank you from all of us at FAN for your recent support for our regional organization. Your financial contribution for this year will be applied toward a Social Grants application to the Columbia Basin Trust in early October. The proposal will be to expand the Check Early Check Often program that FAN has initiated in our region – and bring in new partners School District 20, Interior Health and the Rural Development Institute to help us with this important work. In our school district, we know that 22% (or 110) of our kindergarten students enter school displaying vulnerabilities in one or more critical areas of development. We want to see more children in our region participate in early developmental screening, and to create a system to collect and monitor those screening results. With the important data of the screening results (provided by our partners) we can collectively make effective and impactful investments for early childhood supports where the screening results show us they are most needed. It is our intention to pilot a project that will demonstrate how a collective approach to lowering developmental vulnerabilities in our children before they reach the school system can have tremendous impacts on improving supports and social outcomes for children. This is an innovative and collaborative approach to a population health issue that persists across

UBC Visits the Lower Columbia

In July of this year, we had another visit from a team of UBC researchers from the Human Early Learning Partnership. They were here to present preliminary results from our participation in the Toddler Development Index. The TDI is a new population level tool that has been created to collect information regarding the contexts families today face raising young children. It looks at things such as social supports, financial fitness, parent's health, children's growth and development and neighbourhood or community safety – among other factors. 39 local families participated in this study and their results were collected in early 2017. Researchers are finding important links between positive health outcomes and the factors they are asking families about with this new tool. The Lower Columbia is one of 10 pilot sites throughout BC participating in the TDI with UBC. At the July meeting, we were able to confirm our continued commitment to working with UBC in the ongoing development of the TDI. Once the tool is finalized, it will provide service providers and decision makers in our region with valuable information about the contexts facing our families locally, and allow us to see where we are doing well in supporting local families and where we may consider applying further supports. Christy Anderson, Executive Director for FAN has volunteered to sit as part of a provincial working group to help guide the development of the TDI. It is very important that we continue our partnership with UBC's Human Early Learning researchers, as it will provide us with opportunities for important information, insights and possibly further collaborations.

Ages and Stages Day

October 3rd is a day to mark on your calendars and let local families know about. It is our annual fall Ages and Stages clinic at Kiro Health Centre. Ages and Stages clinics bring together a variety of different early childhood professionals under one roof to provide valuable services to local families – all for free. Services available to families on this day include early childhood developmental screening (using the Ages and Stages Questionnaire), dental and hearing screening and the opportunity to meet with a Public Health nurse for any concerns. Parents appreciate having clear information on the growth and development of their children and to be able to connect to further supports should any concerns be revealed. Since 2014, FAN has facilitated early screening opportunities for 214 children throughout our region. 22% of those children were referred on for

further supports. Families wishing to participate in Ages and Stage day must pre-register. They can do so by calling FAN at 1-855-368-3707.
